

**Motions for the November 2, 2009 Special Town Meeting  
Session 1 – November 1, 2009**

**Article 1:** I move in terms of the article.

**Article 2:** I move to dismiss this article.

**Article 3: Motion A:** I move to amend the action taken under Article 22 of the 2009 Annual Town Meeting – Fiscal Year 2010 Operating Budget to transfer sums of money between accounts to balance the FY 2010 Fiscal Year, by increasing the appropriation and the amount to be raised by taxation for the General Government account by \$153,683 and by decreasing the appropriations and the amounts to be raised by taxation for the following accounts by \$153,683: Public Works by \$31,578, Planning, Conservation, and Inspections by \$67,984, and Community Services by \$54,121.

**Motion B:** I move in terms of the article.

**Motion C:** I move to appropriate and transfer \$\_\_\_\_\_ from Free Cash in the Undesignated Fund Balance of the General Fund to balance the 2010 Fiscal Year.

Under A.

1. Change the permit requirement under Section 3.360.0 in the R-VC District from SPR to SP and to replace “Site Plan Review” in the Standards and Conditions for that section with “Special Permit”.
2. Change the permit requirement under Section 3.360.1 in the R-VC District from SP to N, and remove the second sentence in the Standards and Conditions.
3. Change the permit requirement under Section 3.360.2 in the R-VC District from SP to N.

Under B.

1. Remove the words “An individual” and “direct” from the first sentence of the definition of Medical Offices such that it reads “A medical, dental, or psychiatric practice offering medical or . . .”
2. Remove the words “An individual” from the first sentence of the definition of Medical Group Practice such that it reads “A medical, dental or psychiatric practice including . . .”
3. Remove the word “direct” from the first sentence of the definitions of “Principal Health Care Provider” and “Other Medical Care Providers”
4. Amend the title “Other Medical Care Providers” to read “Other Medical or Dental Professionals”

**Article 10:** I move in terms of the article.

**Article 11:** I move in terms of the article, except for the following:

Under B.

Change the permit requirement for Section 3.360.0, medical offices, from SPR to SP.

Change the permit requirements for Section 3.3840, commercial parking lot or garage, from SP to N and for Section 3.3841, public lot or garage, from SPR to SP.

Under C.

Remove the reference to standards and conditions for 3.3840, commercial parking lot or garage.

**Article 13:** I move to refer Article 13 back to the Planning Board for further study.
