

Motions for the November 4, 2013 Special Town Meeting

MASTER

Article 1: Reports of Boards and Committees

Motion: I move in terms of the Article.

Article 2: Public Art Commission

Motion: I move in terms of the Article.

Article 3: Transfer of Funds – Unpaid Bills

Motion: I move to dismiss the Article.

Article 4: FY 14 Budget Amendments

Motion A: I move to amend the action taken under Article 16 of the 2013 Annual Town Meeting Fiscal Year 2014 Operating Budget by increasing the appropriations and the amounts to be raised by taxation for the Public Safety account by \$63,299, the Conservation and Development account by \$16,653, and the Community Services account by \$19,146 and to meet such increased appropriation by decreasing the appropriation and the amount to be raised by taxation for General Government by \$99,098.

Motion B: I move in terms of part B of the Article.

Article 5: Free Cash

Motion A: I move in terms of Part A the Article.

Motion B: I move that the Town appropriate and transfer \$1,326,223 from Free Cash in the Undesignated Fund Balance of the General Fund to the Stabilization Fund.

Article 6: Capital Program – Debt Repurpose

Motion: I move in terms of the article, except to delete the phrase, "ATM Article 8(C)" and insert in its place, "ATM Article 23".

Article 7: Capital Program – Equipment

Motion A: I move that the Town vote to raise and appropriate \$12,000 to purchase new equipment and to meet such appropriation \$12,000 be raised by taxation.

Motion B: I move that the Town vote to raise and appropriate \$31,700 to purchase, new equipment and to meet such appropriation \$31,700 be transferred from the Ambulance Receipts Reserved for Appropriation Account.

Motion C: To see if the Town will repurpose \$55,167 of funds originally appropriated under Article 19 of the 2013 Annual Town Meeting for the purchase of CPR assist devices and instead use such sum for the purchase of hydraulically assisted stretchers for the Fire Department ambulances.

Article 8: Capital Program – Acceptance of State Grants

Motion A: I move in terms of Part A of the article, except to delete the phrase "previously appropriated funds" and the word, "donations" in line six and insert in its place, "from Article 20 of the 2013 Annual Town Meeting" and "the Puffer's Pond Gift Account," to read as follows: (2) to appropriate and transfer \$36,000, of which \$15,000 shall be transferred from **Article 20 of the 2013 Annual Town Meeting**, \$3,000 from **the Puffer's Pond Gift Account** and any remaining balance...

Motion B: I move in terms of Part B of the article, except to delete the phrase “the Community Preservation Act Fund” in line seven and insert in its place, “Article 24A of the 2013 Annual Town,” to read as follows: (2) to appropriate and transfer \$200,000, of which \$60,000 shall be transferred from **Article 24A of the 2013 Annual Town Meeting** and the remaining balance...

Article 9: Special Act – Abatement of Taxes
Motion: I move in terms of the Article.

Article 10: Watershed Land Acquisition
Motion: I move in terms of the Article.

Article 11: Community Preservation Act
Motion: I move in terms of the Article.

Article 12: Acquisitions of Easements – Pomeroy Lane and West Street Intersection
Motion: I move in terms of the Article.

Article 13: Zoning Amendment –Medical Marijuana Uses
Motion: I move in terms of the Article.

1. In Section 3. b. 6), to place the word “be” between the words “determined to” and the word “sufficient,” so that the phrase reads “determined to **be** sufficient.”
2. In Section 3. c. 2) b), to replace the word “regulations” with the word “regulated,” so that the phrase reads, “at a facility **regulated** under this section.”
3. In Section 3. c. 3), to insert the word “no” between the words “the report” and the word “later”, so that the phrase reads “to present the report **no** later than January 31st of each year.”

Article 14: Zoning Amendment – Affordable Duplexes
Motion: I move in terms of the Article except for the following:

Article 15: Zoning Amendment – Fraternity Residence (R-F) Dimensions
Motion: I move in terms of the Article.

Article 16: Zoning Amendment – Permit Granting Bodies and Signs
Motion: I move in terms of the Article.

Article 17: Zoning Amendment – Dimensional Interpretation

Article 18: Zoning Amendment – Uses Allowed in Mixed-Use Buildings
Motion: I move in terms of the Article.

Article 19: Petition – Zoning Amendment – Uses Allowed in Mixed-Use Buildings
Motion: I move in terms of the Article, except to add the words “or the” after the phrase, Residence Neighborhood (R-N) and delete the proposed phrase in the seventh line of the first paragraph “or the Flood Plane Conservancy Zone”.

Article 20: Petition – Resolution – Divestment of Funds from Fossil Fuel Companies
