- VOTED the following changes recommended by the Parking Commission to the Parking Regulations:

Amend The Permit Parking Regulations By:

- VOTED (2-1) that the regulations shall be in effect from 8:00 a.m. to 5:00 p.m.
- VOTED unanimously (3-0): Allowing Cosby Avenue residents to purchase permits to park in residential area 2 (McClellan Street)

No Parking Areas:

- VOTED unanimously (3-0): ADD no parking on Smith Street from the intersection with Kellogg 20 feet north on the east and west side and to ADD no parking on Smith Street from intersection with Triangle 20 feet south on the east and west side.
- VOTED unanimously (3-0): ADD no parking on north side of Cowles Road from Sunderland Road to first driveway.

Revenue Collection Boxes

VOTED unanimously (3-0) to refer this issue back to the Parking Commission.

Sewer Easement – South Amherst Cemetery

No action taken.

Woodside Avenue Bridge
