**APPROPRIATION and BORROWING AUTHORIZATION ORDER FY22-08A
Town of Amherst Community Preservation Act**

An Order Appropriating and Authorizing Debt for the Special Collections Facility of the Jones Library under Historic Preservation (*2/3 vote required*)

The Community Preservation Act Committee has recommended to Authorize Debt by vote of 8-0-1 for the Special Collections Facility of the Jones Library for which future Debt Service will be paid using Community Preservation Act funds; and


NOW THEREFORE BE IT ORDERED by the Town Council of the Town of Amherst that:

The sum of \$1,000,000 is appropriated under M.G.L. c. 44B, the Community Preservation Act to fund a grant for the purpose of supporting historic preservation, and to meet such appropriation the Treasurer, with the approval of the Town Manager, is authorized to borrow said amount under G.L. c. 44B, §11, G.L. c. 44, §7 or pursuant to any other enabling authority, and to issue bonds or notes of the Town therefore, and any premium received by the Town upon the sale of any bonds or notes approved by this vote, less any such premium applied to the payment of the costs of issuance of such bonds or notes, may be applied to the payment of costs approved by this vote in accordance with G.L. c. 44, §20, thereby reducing the amount authorized to be borrowed to pay such costs by a like amount; and

Be it further ORDERED:

That the Town Manager is authorized to enter into an agreement with Jones Incorporated setting forth the terms and conditions of said grant, including, without limitation, a requirement that an historic preservation restriction be granted to the Town on said property in accordance with M.G.L. c. 184, as required by M.G.L. c. 44B, §12(a); and to accept said restriction on behalf of the Town.
