1. Call to Order

2. Presentations and Discussion

a. Council Order FY21-05B: An Order Appropriating Funds for the Town of Amherst Capital Program – Purchase of a new Ambulance

Finance Director Sean Mangano spoke briefly about the need of a new ambulance. The Town’s oldest ambulance failed inspection and the cost to replace it would be over \$30,000. The cost of a new hybrid ambulance is \$300,000. The funds would come from the ambulance receipts fund.
