An Order Appropriating Funds for a Portion of the Town of Amherst Capital Program – Equipment, Buildings and Facilities (*majority vote*)

BE IT ORDERED by the Town Council of the Town of Amherst that:

The Town appropriate the **sum total \$4,597,178**, for the purchase, repair, and/or installation of new or replacement equipment, for the repair and/or improvement of buildings, and for the repair and/or improvement of facilities, and to meet such appropriation, raise and appropriate \$3,835,656 transfer \$706,651 from the FY21 capital reserve, transfer \$54,871 from repurposed capital and further to authorize the application for and acceptance of any gifts, bequests, or grants.
