**AN ORDER AUTHORIZING THE ACQUISITION OF PROPERTY FOR
SHELTERING, AFFORDABLE HOUSING, SUPPORTIVE/TRANSITIONAL HOUSING
AND/OR SUPPORTIVE SERVICES PURPOSES**

NOW THEREFORE BE IT ORDERED by the Town Council of the Town of Amherst that:

- (a) The Town Manger is hereby authorized to acquire, by purchase, gift, and/or eminent domain and on such terms and conditions as the Town Manager deems in the best interests of the Town, the parcel of land with the improvements thereon located 457 Main Street, Amherst, and described in a deed recorded with the Hampshire Registry of Deeds in Book 2283, Page 208, for sheltering, affordable housing, supportive/transitional housing, and/or supportive services purposes, which acquisition is funded using American Rescue Plan Act (ARPA) funds in the amount of \$775,000; and
- (b) The Town Manager is authorized to enter into any and all agreements and execute any and all instruments as may be necessary or appropriate to effectuate the foregoing acquisition.
