The LSSE Director handed out a Middle School flier and a press release promoting the hours for the new summer Middle School Pool Program. A Brewer asked that the Mill River Pool hours be distributed to the Commissioners and that widespread promotion of the Middle School program continue.

**Early Bidding of War Memorial Repairs**

The LSSE Commission Chair discussed ways that the renovation work at the War Memorial Pool could occur as early as this fall. P. Blier moved that we ask the Town Manager for early bidding to have a more accurate figure to propose to Town Meeting in the fall. M. Whittemore seconded the motion. The motion passed unanimously.

**Comfort Station Update**

The LSSE Director reported on the construction schedule which has been delayed by the June 1<sup>st</sup> tornado due to the ability to connect to electricity. Although a new electric pole was not yet available temporary arrangements were made to operate the baseball scoreboard. The sewer service pipe does not need to be replaced as determined by DPW.
