**Article 23 – Capital Program – Town Center Improvements**

I move that the Town appropriate \$250,000 for the town center roadway, sidewalk and lighting improvements at the following locations:

1. On the east side of North Pleasant Street from Main Street to Kellogg Avenue;
  2. On the west side of North Pleasant Street from Amity Street to Saint Bridget's Church;
- The plans for each component of these improvements to be approved by the Select Board after a duly noticed public hearing, and upon the recommendation of appropriate to board and committees, and to meet such appropriation authorize the Treasurer to borrow in accordance with M.G.L Chapter 44, Section 7(5) and other applicable laws.
