# Proclamation - Human Rights Day

VOTED unanimously to proclaim December 10, 2004 as Human Rights Day.

#### Precinct 7 and 8 – Hampshire College

VOTED unanimously that the description of Precincts 7 and 8 as voted by the Select Board on January 23, 2003 be amended to read as follows (with amendments underlined):

### PRECINCT 7

SOUTH on West Street to unnamed road (Hampshire College Drive – north border of census block 1000 in tract 8208.02).

NORTHWEST on unnamed Road to an unnamed <u>loop</u> road <u>on the campus of Hampshire College</u> (Hampshire College Drive);

NORTH, WEST, SOUTH, <u>EAST and then SOUTH</u> along unnamed <u>loop</u> road <u>on the campus of Hampshire College</u> (Hampshire College Drive) to West Bay Road.

[The remainder of the description remains the same.]

## PRECINCT 8

Beginning at west border of town at West Bay Road:

EAST on West Bay Road to an unnamed road (Hampshire College Drive);

NORTH on the unnamed Road to an unnamed <u>loop</u> road <u>on the campus of Hampshire College</u> (Hampshire College Drive);

<u>WEST, NORTH, EAST and SOUTHEAST on the unnamed loop road on the campus of Hampshire College</u> to West Street;

## **Special Act – Special Election**

VOTED unanimously to petition the General Court and/or the Governor for a special act as follows:

## AN ACT RELATIVE TO THE FILLING OF A VACANCY ON THE AMHERST SELECT BOARD

Section 1. Inasmuch as the full term for the seat on the Amherst Select Board that is currently vacant will be on the 2005 Annual Town Election, the Town of Amherst is hereby authorized not to hold a special election to fill such existing vacancy on the Select Board notwithstanding any provision to the contrary contained in the Amherst Town Government Act, St. 2001, c. 216, and in Section 1.4 thereof.

Section 2. This act shall take effect immediately upon its passage.
