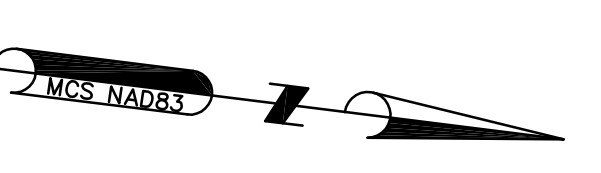
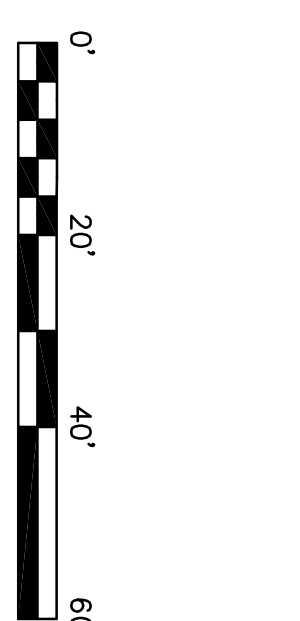
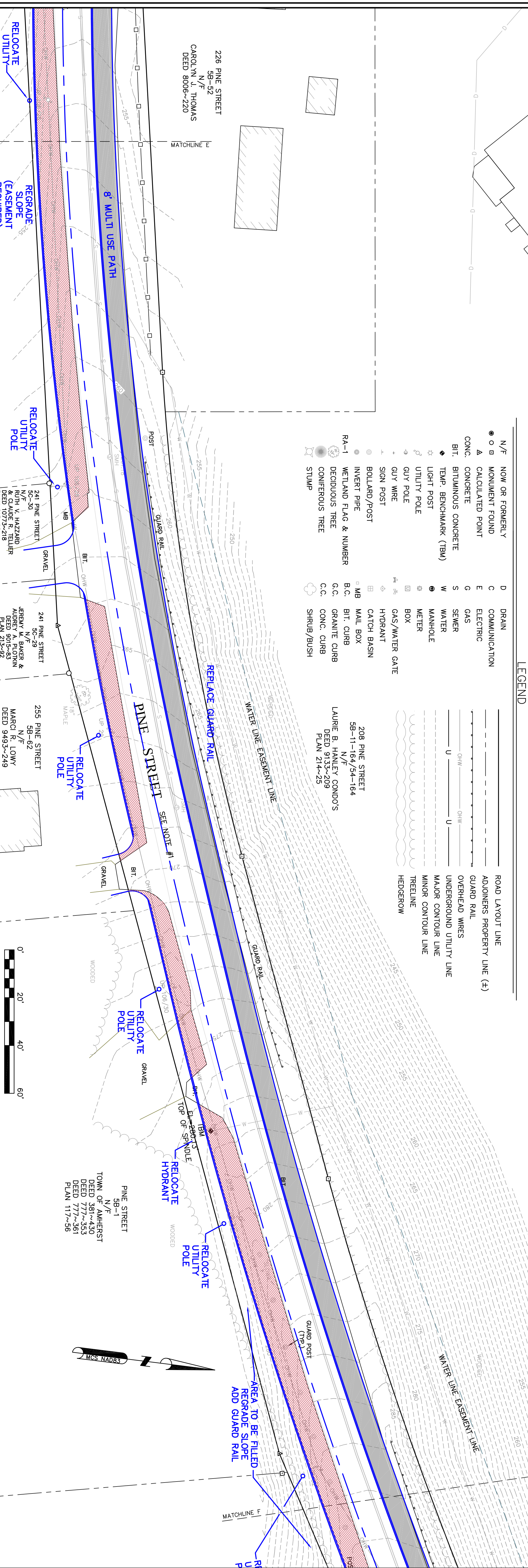

1. PINE STREET (WHICH INCLUDED WHAT IS NOW CALLED BRIDGE STREET) IS AN 1883 COUNTY LAYOUT. IT WAS LAID OUT AS 49.5' WIDE FROM STATION 8 TO 18 (STATION NUMBERS ARE SHOWN AT BOUNDS FOUND AND ANGLE POINTS). THE NORTHERLY SIDE OF THAT LAYOUT WAS ALTERED IN 1933 (PLAN 18-10).
 2. FIELD SURVEY BY EDM TOTAL STATION.
 3. THE HORIZONTAL DATUM OF THIS PLAN IS MGS NAD83. THE VERTICAL DATUM IS NGVD88, & ARE BASED ON A GPS SURVEY USING SINGLE FREQUENCY RECEIVERS & THE NORTHAMPTON CORNS STATION.
