



**TOWN OF AMHERST - RETURN WITHIN TEN (10) DAYS**

Compliance with this state requirement provides proof of residence, protection of voting rights, veteran’s bonus, housing for the elderly and related benefits, and information for the selection of jurors.

**INSTRUCTIONS**

**PLEASE PRINT and make any corrections in the space provided**

- **NAME: List ALL residents at this address:** Include children, those serving in the military, away at school, or at a rehabilitation facility. To add a resident, print their name and information in the space provided.
- **VOTER:** If a letter appears in this field next to a resident’s name, the resident is a registered voter in Amherst.
- **MAIL TO:** Mark a “Y” next to the name of the person to whom the Street Listing form should be addressed.
- **DATE OF BIRTH:** MM=Month, DD=Day, YYYY=Year
- **OCCUPATION:** Provide the profession, not the name of the employer.
- **DECEASED/MOVED:** Print a “D” in the column to indicate the resident is deceased. Print an “M” in the column to indicate the resident has moved from this address. Print the new address, if known, in the \*MOVED section.
- **NATIONALITY:** If the resident is NOT a US citizen, indicate their nationality.
- **VETERAN:** Mark a “Y” to indicate the resident’s status as a veteran of the U.S. Armed Forces.
- **Previous Address:** Provide resident’s previous address if at current address less than one year.
- **Public Safety Employee:** Mark “Y” if resident is a public safety employee. MGL Ch. 51, §4(e)

**2020 Dog License Application**

Dog licenses expire March 31, 2020 and must by renewed by May 31, 2020 to avoid a \$30 late fee  
All dogs 6 months or older must be licensed annually

**To license by mail, first complete the front of this form, then fill in the information below, and return with the following:**

1. A **current rabies certificate** for each dog. The certificate will be returned with the dog’s 2020 license.
2. A **self-addressed, stamped envelope** and a check payable to “**Town of Amherst**” for the appropriate fee (**DO NOT SEND CASH**):
  - \$5 for each spayed or neutered dog, (proof of spaying or neutering must be provided)
  - \$15 for each non-spayed or non-neutered dog

**REMINDER:** The grace period for renewing your dog’s license without incurring a late fee ends on May 31, 2020. Licenses renewed after that date, whether in person or by mail, will incur a \$30 late fee per dog, in addition to the license fee. *If using this form, please allow up to two months to receive the 2020 license.*
